General Data Protection Regulations

From the 25th May 2018, a new data protection law, the General Data Protection Regulation (GDPR) came into force with the intention of strengthening data protection for individuals . Under this new legislation, organisations that hold personal data have to comply with stricter requirements on what they do with that data.

WHAT WE DO WITH YOUR DATA

The HTC uses your personal data for the collection of membership fees , distribution of Cruiser News and dispatching spares and merchandise. A list with current members (who have given their permission) are also sent out to current members.

The data we hold has been provided by you for the above purpose and is not passed to anyone outside of the committee members without specific permission other than for distribution of the Cruiser News by our printers.

STORAGE OF YOUR PERSONAL DATA

Your membership details are stored on a password protected personal computer by a committee member.

After your membership ends, we may decide to keep your details for a number of years to enable you to rejoin the HTC.

YOUR RIGHTS

You have the right to access your personal data and, require that we amend any errors in the data we hold, or on request that we erase your personal data. If you choose to have your data deleted it would inevitably mean the termination of your membership.
